A. Stanford Test Only (no evaluation)..... Fee \$ 35 per student

Optional Add-ons:

A District Home Education Annual Evaluation Form must be filled out for every student and submitted with this form in order to finalize registration with the following add-ons or option B.

**1. Florida certified teacher evaluation based on test results
(form will be mailed directly to the county)* Fee \$ 10 per student**

**2. Florida certified teacher evaluation based on test results including a 15 minute meeting with the certified teacher
(form will be mailed directly to the county)* Fee \$ 25 per student**

B. Florida Certified teacher evaluation based on review of student portfolio and discussion with the student only
(form will be mailed directly to the county)..... Fee \$ 40 per student**

C. Options A & B combined..... Fee \$75 per student

*If a student's test results do not provide sufficient support for the optional sign-off options **1)** and **2)** above, a Florida certified teacher will contact the parent to discuss student progress concerns.

Portfolio requirements (Option **B above) - to be prepared and provided at the time of the review: Provide **ONE single binder** that contains the following:

A list of subjects completed by the student including:

- a. A brief description of each course (such as GHC syllabi)
- b. A list of curriculum/resources used for each course
- c. Grades and/or report cards
- a. A minimum of **6 assignments** (two each from the beginning, middle, and end of the year) for **each** subject that show the student's progression
- b. A list of books read by the student (whether required or independent reading)
- c. A list of extra-curricular activities with a brief description of each

Please have these materials prepared and ready to bring to your portfolio review appointment. Please do not exceed the amount of information requested above. Reviews will be scheduled with the testing coordinator.
