## **OPEN CAMPUS / STUDY HALL**

Our classes meet on an OPEN church campus, where visitors are free to engage in GHC as well as other church campus activities. We have a policy regarding students on the GIBC campus before, between and after classes:

- 1<sup>st</sup> – 3<sup>rd</sup> grade students must be picked up from class and supervised by their parent(s) while on campus.
- 4<sup>th</sup> – 8<sup>th</sup> grade students not in a GHC class are required to attend the supervised Study Hall at all times. Study Hall is for grades 4<sup>th</sup> and up.
- 9<sup>th</sup> – 12<sup>th</sup> grade students are permitted to be in our plaza and cafeteria area when not in class and are not directly supervised.

Parents of any GHC students are welcome to be on campus to supervise their children while not in class(es).

**AS THE PARENT, I UNDERSTAND THAT UPON SIGNING THIS FORM,  
I AGREE TO THE FOLLOWING TERMS:**

**Tuition Fees** per quarter (4 payments an academic year) are \$80 for a 1 hour class, \$120 for a 1 ½ hour class, \$240 for an Omnibus class, and \$160 for a twice-weekly 1 hour math class.

**Facilities Fees** per academic year of \$10 for a 32-week class/\$5 per 16-week class. This once per course non-refundable fee will go directly to Grace Immanuel Bible Church as reimbursement for facilities and maintenance costs.

**Engrade Fees** per academic year per student are \$7 and cover the costs of the online grade communication system.

1. A **non-refundable registration fee** for all classes is now due. (\$50/per individual or \$75/per family). EARLY REGISTRATIONS received before May 31st will have ½ of the registration fee applied towards fees due. (If you pay registration in full, later we will credit ½ towards fees due).
2. A **\$20 prepayment** is required for registration into each class. One hundred percent of the this prepayment will be applied to material, facility and Engrade fees due at the Parent Meeting on August 6<sup>th</sup>, 2018, any excess will apply to tuition due the 1<sup>st</sup> quarter. It will be refunded **ONLY** in the event that the course is not offered or if there are scheduling conflicts.
3. All tuition fees are **due in full** on the first day of each quarter; GHC will also accept monthly payments which are due on the following dates: **August 16<sup>th</sup>, September 13<sup>th</sup>, October 25<sup>th</sup>, November 29<sup>th</sup>, January 10<sup>th</sup>, February 21<sup>st</sup>, March 14<sup>th</sup>, April 25<sup>th</sup>.**
4. Some classes require **Material Fees** to cover classroom and laboratory supplies, textbooks and/or workbooks. These fees are listed in the course descriptions. **They are due and payable at the August Parent Meeting** and are non-refundable. However, **most classes require textbooks or other resources that must be purchased individually.**
5. Once the registration form and any tuition prepayments are accepted, a student(s) will be tentatively placed on the class roster dependent upon the GHC board's student admission acceptance criteria.
6. Parents will receive registration instructions by email for Engrade, the GHC online course management and communication system. Parents are responsible to register on Engrade. **Weekly responsibilities of parents include the following for EACH class:** the printing of all assignments, the daily signing of all homework sheets when all work is completed, and the consistent oversight of student progress assigned by instructors.

7. Parents must communicate with instructors via email, Engrade messaging or by phone if there are concerns or needs, a planned absence, or if a student is ill. Necessary arrangements must be made for missed lessons.
8. A current email address must be maintained and checked weekly in order to stay informed of any program information. **Please notify Melissa Schubert at [melificent@me.com](mailto:melificent@me.com) if you do not receive weekly GHC emails.**
9. **DROP FEES of \$50 per class apply** to any course dropped during the year. **Omnibus classes have a double drop fee of \$100** as they are equivalent to multiple courses. Please notify the teacher **and** Sandy Gray ([gharryjr@bellsouth.net](mailto:gharryjr@bellsouth.net)) IMMEDIATELY upon withdrawal from any course as a courtesy to the instructor and to avoid tuition charges from that date forward. Tuition charges will remain in effect until GHC has been properly notified of withdrawal.

IMPORTANT: The PARENT is the HOMESCHOOL EDUCATOR and GHC instructors are ASSISTING in that capacity. Grace Homeschool Connection is not a SCHOOL; it is a ministry that exists to HELP the Homeschool Educator.
